CAMP THUNDER TERMS & CONDITIONS

1.1 Product: Camp Thunder reserves the right to change any of the clinic package details including locations, dates and times at any point in time. Camp Thunder reserves the right to not accept any registration for clinics in its absolute discretion.

1.2 Venue & Equipment: Registrants are expected to adhere to all guidance by Camp Thunder coaches, staff, and other representatives in relation to treatment of camp venue and venue property and equipment. Cricket NSW shall not be liable for any matters related to damage to clinic venue, property and equipment and will pass on any incurred costs as a result of damage to the participant at fault.

1.3 Cancellation, Refunds and Replacements: Once your registration is sent to the Club you cannot cancel your booking, without limiting clause above, refunds and exchanges are allowed only as expressed in this Agreement. In the circumstance that the clinic is cancelled due to wet weather, fees will be credited to the next school holiday clinic only. Please note that credits not used at the next school holiday clinic are forfeited and cannot be refunded. 2 day wet weather cancellation = \$100 credit, 1 day wet weather cancellation = \$100 credit. Credits are not pro-rated if a clinic is cancelled during the day. If there is more than one and a half hours play, no credits are applied. If there is less than one and a half hours play, a full day credit will be issued. Camp Thunder also reserves the right to cancel any registrations at any time if, in the Club's opinion, a participant engages in disruptive behaviour which is deemed inappropriate (physically or emotionally), or likely to be prejudicial, to the interests of fellow participants, coaches, staff members or other related parties.

1.4 Privacy Policy: Camp Thunder respects the privacy of the individuals on whom it collects, uses and discloses personal information. The personal information that the Club collects is used for the purpose of processing your registration and providing you with cricket related information and offers from the Club.

A copy of Sydney Thunder's Privacy Policy is available to any member upon written request.

1.5 Use of Images: Sydney Thunder advises that photographic and film images of participants at each clinic may be used for the purpose of promotion and marketing of the game. If you do not wish the participant to be used, you must supply in writing or at time of registration your non approval.

1.6 Liability of Injury: The participant and their parent understands that by submitting their registration to Camp Thunder, that participating in Camp Thunder carries with it inherent dangers and/or risks of physical injury, including serious injury such as permanent disability, paralysis and even death. The participant and their parent understands that they are voluntarily participating in the Camp Thunder with knowledge of the potential dangers and/or risks involved.

1.7 Liability of Personal Items: Whilst Sydney Thunder uses best endeavours to select appropriate secure locations for our holiday clinics, registrants and their parents acknowledge that Sydney Thunder takes no responsibility for personal items that are lost.
